INSTRUCTIONS

The Application for License Manufacture, Storage or Transportation, is to be filed to apply for a new Alternating Brewer, Brewery, Distillery, Distillery of Historical Significance, Limited Distillery, Winery, Limited Winery, Bonded Warehouse, Bailee for Hire or Transporter-for-Hire, AND to apply for the transfer of Transporter-for-Hire, Class B (in Pennsylvania ONLY), Alternating Brewery or Brewery. All questions must be answered. All attached separate sheets must include the applicant's name and the address of the establishment.

Fees and documents to be submitted with this application include:

1. FEES – For a new license application, a filing fee of \$700.00, AND a license fee of:
 - a. \$1,425.00 (pro-rated quarterly) for a Alternating Brewer or Brewery, and if question 18b is answered yes, a \$100.00 fee for a Sunday Sales permit, OR
 - b. \$265.00 (pro-rated quarterly) for a Bailee for Hire, Bonded Warehouse, Transporter-for-Hire, Class A, OR
 - c. \$385.00 (pro-rated quarterly) for a Limited Winery, or for a Winery, OR
 - d. \$5,400.00 (pro-rated quarterly) for a Distillery, or for a Distillery of Historical Significance, OR
 - e. \$160.00 for a Transporter-for-Hire, Class B, OR
 - f. \$265.00 for a Transporter-for-Hire, Class C, OR
 - g. \$1,500 for a Limited Distillery.

The fee to transfer an existing Transporter-for-Hire, Class B, in Pennsylvania ONLY, Alternating Brewery or Brewery, is \$650.00 for person to person, \$550.00 for place to place, OR \$700.00 for both person to person and place to place.

Make all remittances payable to "PLCB" or "Commonwealth of Pennsylvania." Fees submitted by applicants from outside of Pennsylvania MUST be certified checks or money orders.

2. PLCB-1773, Appendix Social Security Information MUST be submitted showing the social security number(s), name(s), and title(s) of each individual applicant, partner, member, OR for a corporation, of each officer, director, stockholder, and manager.
3. Tax Certification Statement (PLCB-1898) by applicants for Transporter-for-Hire, Class B, located in Pennsylvania AND by applicants for Alternate Brewer and Brewery.
4. A request for Criminal Record Check (PLCB-2018) by applicants for Bailee for Hire, Brewery, Distillery, Limited Distillery, Limited Winery and Winery for EACH individual applying as an individual licensee, or as a partner, or as a member, or as an officer of a corporation, or manager, with a \$10.00 remittance per form.
5. Blue prints of the plant, property and apparatus by applicants for Brewery, Distillery, Winery and Limited Winery.
6. Alternating Brewer and Brewery applicants may apply for a "Brewery Pub" license to operate a restaurant or brew pub on the licensed premise permitting sale of malt or brewed beverages produced and owned by the Alternating Brewer or Brewery respectively. A separate application packet is required.
7. PLCB-21, Application for Transfer of License and Permit. If for transfer of an existing license see PLCB 21 for required fee.
8. Owner of premises name, address, principals and their titles must be listed.
9. LIMITED WINERY: Recent, individual photographs of each applicant, partner, member, manager and of each of the principal officers. 1½" x 1½" in size, identified with the individual's name and applicant's name and address of the premise on the reverse. Photographs must have a matte finish.

Recent premises photographs, 4" x 6" in size, of the exterior of the premises showing the main entrance and the main interior serving/sales area with the applicant's name and address of the premise on the reverse. Photographs must have a matte finish.

INFORMATION

DO NOT SUBMIT ANY OTHER DOCUMENT (E.G.; LEASE, AGREEMENT) WITH THIS APPLICATION PACKET. SHOULD YOU BE REQUIRED TO SUBMIT SUCH DOCUMENTATION, OTHER THAN FOR THE INVESTIGATION OFFICER'S REVIEW, YOU WILL BE NOTIFIED IN WRITING.

An application for new license or for the transfer of an existing license to a new location not presently licensed may be filed for "PRIOR APPROVAL" of planned alterations or construction. Submit a site plan clearly showing the premises proposed to be licensed as it will be upon completion of the alterations or construction of the building. A site plan must be on 8½" x 11" paper depicting the location of the proposed premises in relationship to identifiable lines or easily identifiable landmarks or reference points with measurements to the property lines, landmarks or reference points. The plan must be clear and readable.

IF VEHICLES ARE USED TO TRANSPORT LIQUOR, MALT OR BREWED BEVERAGES OR ALCOHOL IN THE REGULAR OPERATION OF THE BUSINESS, YOU ARE REQUIRED TO:

1. Display on each side of each vehicle used to transport alcoholic beverages, the license number (preceded by PLCB), the licensee name and address including the street name and number as shown on the license in letters no smaller than 2 inches in height. Transporters-for-Hire are exempt from the requirement.
2. Own or lease the vehicle used. The vehicle owner may not have any proprietary interest in any business licensed by the board.
3. A Transporter-for-Hire may transport alcoholic beverages as dictated by the permit type, in vehicles owned or leased by the licensee and operated by drivers employed by the Transporter-for-Hire, or operated by unlicensed transporters who are under contract with the Transporter-for-Hire.
