Pennsylvania alcoholic beverage law and regulations require every person, except Pennsylvania Importers, who sell liquors (other than wine) which have not been manufactured in Pennsylvania to the Pennsylvania Liquor Control Board to obtain a Sales Permit. The fee for this permit is equal to that required of a Pennsylvania manufacturer to do business in the state of origin of those liquors.

The following schedule lists the Sales Permit fees required for the sale of liquors (other than wine) which are manufactured in the states indicated. Fees for liquor manufactured in foreign countries or territories will be determined by the Board upon application.

Pennsylvania Importer licenses are issued by this Board to Pennsylvania residents and Pennsylvania corporations as well as out-of-state corporations which have obtained the necessary authority from the Pennsylvania Department of State and Department of Revenue to do business in the Commonwealth. Out-of-state applicants for this license must also establish a place of business in Pennsylvania. Application forms and fee information for this license may be obtained from the Pennsylvania Liquor Control Board, Bureau of Licensing.
